ANNEXURE -II

Terms and conditions

- 1- The tenderer shall quote the rate Exclusive of **Service tax**. The service tax on the services rendered under work contract shall be paid Extra in terms of clause 2A(ii)(A)/(B)/(C) (as the case may be) of the service tax determination of value Rule, 2006, read with notification no.30/2012-ST dated 20.6.2012. In case the bidder is a company, then entire applicable service tax shall be deposited by the bidder and the same shall be reimbursed by the company subject to submission of documentary proof of deposition of ST with the Govt.
In case the bidder is other than a company then 50% of the applicable service tax shall be deposited by the company and 50% of the applicable ST shall be deposited by the bidder which shall be reimbursed by the company subject to submission of documentary proof of deposition of S.T. with the Govt. Bidders are requested to quote accordingly.
- 2- Rates and tax deduction at source:- All taxes/duties/levies as are applicable Except service tax should be taken into consideration while making the offer. Ignorance in it shall not qualify for any additional payment. RSMML will reimburse/recover at actual any tax/duties which are imposed/ increased/withdrawn/decreased after the date of submission of offer & are directly applicable to this contract and payable by the contractor/recoverable by RSMML, and determined on the basis of bills raised by him upon the company, if applicable, subject to the furnishing of documentary proof. The company shall be fully entitled to deduct Income tax and / or other taxes levied at source as per the rules and instructions as may be applicable for this purpose from time to time.
- 3- Criteria for deciding L-1 bidder :- The bidder whose quoted rates are resulting into the lowest financial outgo for the company for the total scope of work will be considered as L-1. The total contract value will be arrived by (Rate per unit per annum X no. of units) considering the total liability of service tax (as applicable under service tax w.e.f.1.7.2012) the final figures as achieved will decide the total contract value for the purpose of deciding the L-1 bidder.
- 4- The successful bidder shall have to deposit 10% of value of contract as security. The same will be refunded after completion of satisfactory work of contract.
- 5- The representative of firm/company shall report to Sr. Manager (Administration) & will attend the complaint within 24 hours. The quality of water should be checked once in month
- 6- The firm/Company shall use only ISI marked material whenever providing new items or repairing old items.
- 7- The period of contract will be of 1 year from the date of award which can be further extended on mutual consent for another 06 months on same rates, terms & conditions

- 8- The contractor shall be responsible to keep the RO systems in working order. In case any defect occurs, the same should be rectified within 48 hours. If the system is not brought to working order within 48 hours (excluding holidays), a penalty of Rs. 250/- per day will be imposed. The contractor shall replace all defective parts (consumable or otherwise) free of cost. Only those firms who have access to spare parts should submit quotations. If any system goes out of order frequently, it would be treated to the out of order for the entire period of the contract. No payment shall be made for the repair/maintenance of such a system.
- 9- The work which is not possible to be carried out or completed in the office premises will be allowed to be done outside the office premises, but no extra charges would be paid for the same.
- 10- No advance payment will be made in case of providing and repairing of R.O. items.
- 11- Payment will be made on quarterly basis. The final payment shall be made only if all the systems are in working order and certificate to this effect submitted by Sr. Manager (Administration).
- 12- The firm/company should have its own well established workshop and possess experience of doing work in the Govt. Offices or reputed organizations. Proof thereof needs to be submitted along with the quotation.
- 13- The RSMML shall have no liability, financial or otherwise, for any harm/damage/injury incurred by the manpower deployed by the contractor in the course of repairing R.O. at Corporate office, Udaipur. Neither the Contractor nor his workers shall any claim on RSMML for compensation or financial assistance on this account.
