PRICE CIRCULAR

The price and sale terms of Gypsum/ Selenite on physical dispatches w.e.f. 03.01.2024 shall be as follows:

1. BASIC SALE PRICE:

- i) Royalty will be extra as applicable from time to time as declared by Govt. / Statutory authorities. At present it is Rs.200/- per metric ton for Gypsum and Twelve percent (12%) of basic sale price for Selenite.
- ii) Contribution of 10% of Royalty to District Mineral Foundation Trust (DMFT) for Gypsum and a contribution of 30% of Royalty to District Mineral Foundation Trust (DMFT) for Selenite shall be extra.
- iii) Contribution towards Rajasthan State Mineral Exploration Trust (RSMET) for Gypsum is 2% of Royalty at present, which shall be extra, NIL for Selenite.
- iv) Contribution towards National Mineral Exploration Trust (NMET) for Gypsum is Nil and a contribution of 2% of Royalty to National Mineral Exploration Trust (NMET) for Selenite shall be extra.
- v) Processing fee @ Rs. 10/- on generation of each e-rawanna shall be extra.
- vi) CGST, SGST and IGST shall be charged extra as applicable. Intra-state transaction will be levied with Central GST (CGST) and State GST (SGST). Inter-state transactions will be levied with Integrated GST (IGST) by the Central Government.
- vii) At present GST Rate is 5%.
- TCS shall be deducted on the advance receipt which is @0.1% at present.
- ix) Any revision in duties, taxes, levies etc. as and when made applicable by the Govt. shall be passed on to the buyers.



- x) RSMML will not be responsible for quality (purity) and quantity after consignment leaves the dispatching points. However, Customer may pre inspect the material and may draw joint samples from Mines before loading into Trucks.
- xi) This Price Circular supersedes all earlier Price Circulars issued by us.
